



FLOOD AND DROUGHT RESILIENCE


Connected floodplains allow floodwater to spread out and sink in. River Partners is advancing California's climate resilience with the state's largest footprint of floodplain reconnection projects.

2020 was our largest dedication to date.



GENETIC DIVERSITY

River Partners collects and propagates native seeds for all of our restoration work, often pioneering the cultivation of native plants that have **never been cultivated before.**

In 2020, we propagated 27 different species, including the state's largest production of milkweed – the host plant for the Monarch butterfly.



CARBON SEQUESTRATION

A new five-year partnership with the Joseph and Vera Long Foundation and California Waterfowl Association is **expanding** the science of carbon sequestration in river forests across California.

PARTNERS IN RESTORATION

River Partners was honored in 2020 to work with the following Regional Conservation Corps and dozens of Corpsmembers on projects that included removing over 400 acres of invasive weeds and planting more than 200,000 native trees and shrubs.

Predation of endangered riparian brush rabbit in restored habitat;


River channel migration and mapping;

Reconnected habitat across **31 river miles** this year.



LAND AND WATER RESTORATION

Over **2,000 acres of reforestation** dedicated in perpetuity for future generations this year.

River Partners contributed to the recovery of over 20 endangered species this year through:

Habitat restoration and land acquisition; Population studies and surveys; Living laboratories for research.




